I have been retained by Mr. Rickford Burke to take legal action against you and your media publication "NEWGUYMEDIA.COM" for libelous, slanderous and defamatory material published therein on January 30, 2013 under the headline "**APNU OFFICIAL RICKFORD BURKE CHARGED WITH IDENTITY THEFT, FACES 3-7 YEARS IN PRISON.**"

According to records, you registered "NEWGUYMEDIA.COM" with FastDomain Inc. on November 14, 2012 at 17:43:57 GMT and hired BlueHost.Com as your web-host.

As the registered owner and publisher of this site, you may be found liable for intentionally maligning my client on the internet under the guise of reporting factual information.

As of January 31, 2013, there is no corporate entity with the name NEWGUYMEDIA.COM. I will therefore proceed to sue you personally in New York State Supreme Court.

This article about my client that was published in "NEWGUYMEDIA.COM" is completely false, erroneous, libelous, slanderous, defamatory and has no basis in fact. It has caused severe damage to his name, reputation and professional image. I am therefore directing you to remove it from your website forthwith and publish a full and complete retraction and apology, approved in advance by me, in a similarly conspicuous place as the defamatory article.

My client has suffered extraordinary damages resulting from NEWGUYMEDIA.COM's intentional and reckless publication of false information.

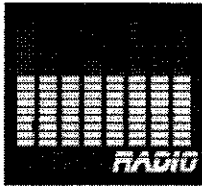

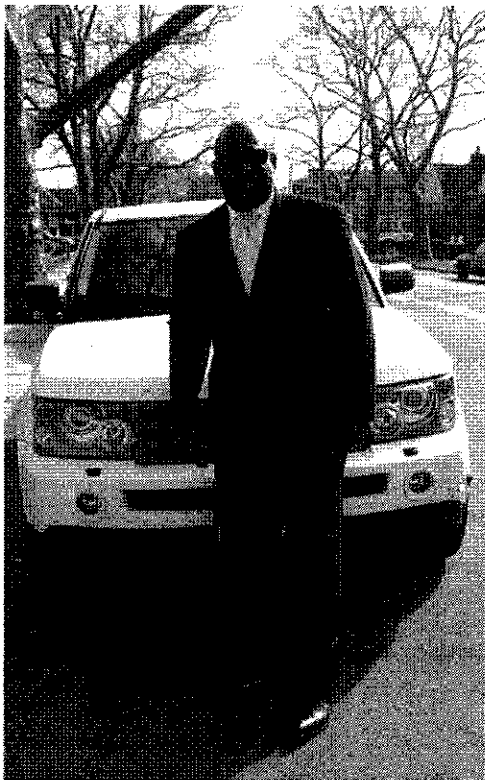

APNU OFFICIAL RICKFORD BURKE CHARGED WITH IDENTITY THEFT, FACES 3-7 YEARS IN PRISON

Senior figure in the PNC(now APNU) New York chapter Rickford Burke was arrested on January 15th last and charged for identity theft. US prosecutors are alleging that Burke bought himself a Range Rover SUV on the credit of another person by falsely pretending to be that individual. According to New York laws;

"A person commits the most basic form of identity theft as defined in the New York Penal Code when he or she "knowingly and with intent to defraud assumes the identity of another person by presenting himself or herself as that other person, or by acting as that other person or by using personal identifying information of that other person," and additionally (a) obtains goods, money, property or services or uses credit in the name of such other person or otherwise causes financial loss, or (b) commits a class A misdemeanor or higher level crime"

Burke is charged with first-degree identity theft as "the total amount of goods, money, property or services, credit used, or other financial loss caused thereby exceeds US\$2000". He faces up 3 to 7 years in prison. Burke served as a former personal assistant to then PNC leader and President of Guyana, Hugh Desmond Hyote and migrated to the US following the PPP/C's ascension to office in 1992. He's currently a central figure in the PNC(now APNU) New York chapter and is also a frequent letter writer to the local dailies as well as a fervent critic of the PPP. He is expected to make another court appearance on February 23rd at the Kings Criminal Court.
